

SWEEPSTAKES OFFICIAL RULES

"Debby Boone - Reflections of Rosemary" Giveaway Sweepstakes ("Sweepstakes") starts at 9:00 AM ET on Thursday, February 2, 2012 and ends at 12:00 Midnight ET on Thursday, February 23, 2012 ("Sweepstakes Period"). This Sweepstakes shall be subject to these Official Rules, and by entering, each entrant agrees to abide and be bound by these rules and the decisions of the judges and Sponsor.

1. Eligibility: This Sweepstakes is open to legal U.S. residents residing in Broward, Miami-Dade, and Palm Beach Counties, Florida who are 18 years and older as of the first day of the Sweepstakes Period. You can leave a message anytime including weekends and we will take your requests. You must provide your name, address, telephone number and date of birth to the operator or answering machine and the name of the sweepstakes you wish to enter. In the event of a dispute regarding the identity of an online entrant, the holder of the email account will be deemed the person who submitted the entry. In the event of a dispute regarding the identity of a telephone entrant, the holder of the telephone number will be deemed the person who submitted the entry.
